











executive director - president report

For a relatively young charitable organization, each year that passes becomes like a brick laid in a pathway. We move inexorably forward, laying in a direction for the future. Our task as staff, volunteers, donors and a community is to ensure that each year moves us further on the best path; that each stepping stone is well placed. After all, we want to go in the right direction and many are going to use this pathway in the future.

2012 brought the Community Foundation of Mississauga further along in the journey.

This year, the Foundation provided over \$650,000 in grants. Some of the stories of these grants are included in this report, but once again, every sector of our community's charitable programs and services were represented, including the environment, health and healthy living, children and youth, education, arts, culture and heritage and more. Despite the relative youth of Mississauga's community foundation, the organization is having real impact. Donors have made this possible!

Last year we welcomed new funds; the Crase Family Fund, the Landscapes for Life Endowment Fund and the Scott and Steve McNair Memorial Fund. We were also thrilled to participate in a short term flow thru fund that resulted out of a unique collaboration between Community Foundations of Canada, True Sport and Toronto Pearson. Thanks to these partners, over \$30,000 was made available to provide essential programs serving the Malton area. One of these initiatives is highlighted a little further on in this report. And in 2013, we are excited to be seeing one of these grants at work providing youth leadership opportunities and healthy sport for teens in Malton.

The Foundation is rapidly becoming a trusted, cost effective tool for donors interested in establishing their philanthropic legacy no matter what the cause they are interested in supporting. But local corporations also stepped up to the plate, demonstrating their social responsibility through our Partnership Program. This initiative achieved significant growth and some outstanding marketing opportunities for participants.

The Ontario Trillium Foundation once again demonstrated their commitment to building healthy and vibrant communities by strengthening the capacity of the voluntary sector, through investments in community-based initiatives. The Foundation was truly grateful to be approved in 2012 to receive a grant to purchase a new database. While on the surface, a new database might not sound exciting, our team was certainly thrilled. The new database will enable the Foundation to enhance our accountability to donors and the broader community, increase the efficiency and accuracy of our activities and provide a scalable platform able to meet the changing needs of a growing community foundation. The support of the Trillium Foundation will result in cost savings and greater accountability for years and years to come. It is where we needed to go on our journey.



We also began work on a powerful new initiative that is taking shape at community foundations all across Canada. When His Excellency the Right Honourable David Johnston, Governor General of Canada, gave the opening address at the Community Foundations of Canada 2011 Conference, he spoke passionately about his desire to

make Canada a smarter and more caring nation. As patron of Community Foundations of Canada, he asked community foundations across the country to consider ways they could contribute to this vision. His call to action inspired and motivated the national movement - and Smart & Caring Communities is the response.

In Mississauga, we join with our community foundation peers across the country in imagining what is possible. And we believe that a smart and caring future for our community starts with an investment in our children and youth. We assembled a great team of volunteers who will help us build towards a goal that will help ensure that every child in our community has the tools and opportunities they need to reach their potential. In 2012, we took some of the first steps on this path and as we move forward, we are inviting you to become part of this national effort. Imagine what will be possible.

In addition to flexible, comprehensive fund options, donors increasingly look to the Foundation as a source of knowledge about community needs. More and more, donors and indeed the broader community want to know how they can make the best use of their resources. The Community Leadership Committee was very active during the year ensuring that we fulfil our mandate as a community knowledge leader. Using key data points from Vital Signs, the committee brought together sectors leaders in both housing and the arts and created a place for conversation, resource sharing and ideas. The conversations and knowledge were then distilled into easy to read reports accessible from the Foundation's web site.

Our **Investment Committee** began work on a comprehensive Investment Manager Review process as part of the ongoing due diligence of the Foundation. This volunteer team of industry leaders gave countless hours of time to review best practices, develop a rigorous process and ensure that the Foundation's had the best possible options to consider. We look forward to the next steps as their work continues.

Our **Donor Development Committee** had a busy and successful year with several exciting events hosted by the Foundation in 2012. This team implemented the Speakers Lunch featuring Jeff McInnis, which was a highlight for business people and community advocates. The Golf Tournament at Piper's Heath was a great day of golf, networking, and special guests. These Foundation events were complemented by events held by others in support of the Foundation. We would like to acknowledge two very special partners Canyon Creek Square One and Advocis Peel Halton for their stalwart and truly valued support.

As the year drew to a close, the Foundation said farewell to four amazing individuals on the Board of Directors. **Steven Offer, Tom Cooney and Peter Campbell** completed all terms as allowed under the organization's bylaws and **Gary Reamey** retired. Each of these volunteers gave countless hours, shared their skills and expertise and strengthened the Foundation. So much of the path we have charted for the future is due to the leadership of these individuals. But we only say farewell. As donors and committee volunteers, we plan on using their wisdom for years to come!



Finally, every year, indeed every day of each year, we acknowledge and extend appreciation for our donors. As each year the Foundation grows and increases its impact on community vitality through a growing number of grants, we are always cognizant that it is donors that make this possible. 
EMERGING FUNDS



landscapes for life

The Credit Valley Conservation Foundation (CVCF) believes in the concept of "landscapes" as being an expanse of scenery that can be seen in a single view; a view that is offered, available and valued by everyone who lives, works or plays in the Credit River Watershed, and a view that is important to respect, protect and preserve. They understand that "life" not only pertains to all living creatures in the watershed, but also to the never ending opportunities that exist to effect change today that will matter lifetimes from now.

It is this powerful idea of effecting change today that will matter lifetimes from now, that aligns so closely with the Community Foundation of Mississauga and part of what led to an exciting new partnership between the two organizations.



Across Canada, many community-based charities turn to their local community foundation to establish an endowment for their organization. The reasons are extensive and varied. respect, protect and preserve

rocking mississauga, bollywood style

Truly multi-cultural, the Bollywood Monster Mash Up project livened up Celebration Square at the City Centre by bringing together all of Mississauga. Held in July 2012, this second annual arts festival featured a free evening of live entertainment centred on the fusion of Bollywood with non-South Asian cultures. The turnout of almost 15,000 attendees was mesmerized by more than 80 singers, dancers and musicians over a feet-tapping four hours.

The highlight of the evening, one that embodied the Community Foundation of Mississauga's spirit of inclusivity, was the pairing of the Mississauga Choral Society with Indian lead singer, Ferzana Bohra's performance. An accompaniment would not usually be a surprise, except they all sang in Hindi and Urdu, native languages of India and Pakistan, respectively. The Choral Society trained for days using 'transliteration', a method of breaking down words into syllables and then identifying sounds. But it was well worth the practice as the crowd was enthralled by the cross cultural performance.

The Monster Mash Up represents to the core the Foundation's values of building community vitality, understanding our communities, creating opportunities for inclusion and embracing partnerships.

These objectives were all met when Mississauga citizens came together for a diverse and highly accessible arts and culture experience involving excellent quality local artists and cultural groups, and by creating economic opportunities in the area, a triple win!

The event was considered a success by the audience it engaged and the feedback that was returned. It went a long way in creating a genuine sense of appreciation of other cultures and the desire to accept and welcome the diversity that makes us a strong and vital community. This event was made possible in part through a grant from the Pendle Fund at the Foundation. This fund works much like a private family foundation in terms of all the benefits. But because it is a donor-advised fund held at the Foundation, the donor can take advantage of efficiencies, community knowledge and the administrative support.



a lasting legacy for mr. bow tie

They called him Mr. Bow Tie and by all accounts, and there are many in Mississauga, he was one of Mississauga's best loved realtors. Paul Coughlin has been described as one of a kind. You would be forgiven for thinking that description was based on his natty attire. He would sport creative, brightly coloured jackets and shirts.... but always a bow tie. His reputation for his lively garb preceded him and made colleagues and friends smile. That's probably why he did it; it made folks smile. But that's not what made Paul one of kind, that description came as a result of his compassion for community.

Many realtors in Mississauga will tell you, Paul was always first in line with a hand up when someone was struggling. An encouraging word, a shoulder to lean on, a few bucks to tide someone over, he was always happy to help. And when it came to supporting charitable causes in the community, you could count on Paul to be right there.

Paul and his business partner, Bill Croft were instrumental in starting a golf tournament in the mid - 1970's that raised close to \$1 million dollars for charities.

Paul Coughlin died in 2002 but the impact of the vibrant life he led and his caring for others carries on. In his memory, the Mississauga Real Estate Board has named their annual golf tournament in Paul's honour. Funds raised annually in part are dedicated to the Paul Coughlin Fund at the Community Foundation of Mississauga. Each year, grants from this fund go back out to support community charities serving children with physical or developmental disabilities.

For the Foundation, there is a special significance attached to this fund in that it was the first fund opened at the fledgling community foundation. Part of Paul's legacy of a "hand up" extended to this young charitable organization, helping it also to get on its feet.

Paul's wife Mary Hurley notes, "It has been wonderful to see how much this fund we created to honour Paul has meant to so many; the charities who receive grants, the children and families who benefit and the community foundation that has grown so much as well. Our family is grateful to everyone who has given generously and volunteered their time to help this fund grow."





imagine...

every child playing a sport

a love of sport

Can you hear it? Hockey has a unique sound; the thunk of a puck hitting the boards, skate blades slicing across the ice, the whack of a stick hitting the ice calling for the pass of the puck, eager fans and team mates cheering. It is no surprise that hockey has become the favourite past time of many Canadians, our winters accommodate the game so well. Frozen ponds, homemade back yard rinks, indoor rinks and even an open patch of asphalt in the summer will suffice till winter comes again.

But for many children in Malton, hockey was a brand new experience. They watched the televised games on Saturday nights but the equipment and access was simply out of

reach. Their parents were struggling to put down roots and build a home in a country that was new to them. "Hockey is not played in many of the countries represented in Malton and as a result, the sport has declined dramatically in Malton in the past decade." noted the Peel Family Education Centre. But hockey sure looked like fun.

Like many sports, hockey has a lot to offer. Sport Canada notes that 72 percent of Canadians believe that sport is a key contributor to quality of life in their communities. Further, sport can help newcomers integrate more quickly into Canadian society by improving relationships among people of diverse ethnic backgrounds, breaking down barriers, building confidence, and providing links to community services and support.

True Sport notes, "In every province and territory, community sport inspires friendship, learning, health, and personal growth. Canadians tell researchers that after the family, sport is the most powerful influence on young people's development."

Thanks to the partnership of **True Sport** and **Toronto Pearson**, the Community Foundation of Mississauga was able to make a grant to The Peel Family Education Centre to bring youth hockey to Malton.

The grant helped the organization purchase equipment for the children, the most cost-prohibitive element of participation for many kids. Further, much of this equipment can be used for about five years, creating a "bank" of hockey equipment for the children.

The community response has been tremendous! Volunteers in the community were energized and residents who could afford to, donated additional equipment.

The first group of children to participate in this program graduated from the twelve week program in December. And the next session was already fully booked. One mom noted that this was the first time her son had the opportunity to play hockey, the cost of other programs being too expensive.



Bringing hockey back to Malton means much is learned about teamwork, cooperation, community, fitness and leadership. But for the kids, well... hockey is just great fun!

condensed financials

1. Significant Accounting Policies

Investments:

Investments are valued at fair market value. Investment income, including realized and unrealized gains net of losses, is allocated to the pool of Endowment Funds, Long-Term Flow Through Funds, Operating Funds and Funds Held for Others.

Funds Held for Others:

Funds held for Others represent community agency funds pooled with the Community Foundation of Mississauga for investment purposes. Investment income is allocated to the funds on a proportionate basis and the agencies are charged a management fee by the Foundation.

Long-Term Flow Through Fund:

Flow Through Funds are gifts to the Foundation that are generally expected to be held for a term from not less than one year and not more than ten years. The capital and investment income from the Funds will be granted to qualified donees in accordance with the terms of the Fund agreement.

Endowment Fund:

Donations to the Endowment Funds are considered to be permanent in nature, pursuant to restrictions established at the time that donations are received, and only the investment income from the investment of such Funds is disbursed to charitable organizations.

Infrastructure Fund:

The infrastructure fund was created from an externally restricted grant from the Ontario Trillium Foundation. The resources are to be used to enhance the capacity of the Foundation.

2. Investment Management

Investments are professionally managed in accordance with the investment policy of the foundation by Toronto Community Foundation, B2B Bank Securities, and BMO Nesbitt Burns.




